- I acknowledge that my child may be asked to leave the conference should he/she exhibit any behavior in direct contrast to guidelines and safety measures.
- I acknowledge the contagious and evolving nature of SARS-CoV-2/COVID-19 virus and voluntarily assume the risk that my child may be exposed to the virus and become affected as a result.
- I understand the risk of becoming infected may impact other students, staff and participants’s families or personal contacts.
